
LAKE REGION ARTS COUNCIL NEWS

REGION VI CONVENTION - AGO JUNE 18-21, 1995 Kansas City, Missouri

Six members of the Red River Valley Chapter of the American Guild of Organists were in attendance as the Greater Kansas City Chapter hosted Region VI members this past June. Attending from our Chapter were: Marlys Herring, Michael Olson, Dawn Papenfuss, Rod Rothlisberger, Bradley Steen, and Barry Wenger. The days spent is Kansas City were filled with opportunities to be challenged, inspired, as well as be exposed to numerous resources that would cause us to grow as church musicians.

Those in attendance from within Region VI, as well as from other areas of the country, were also given an opportunity to face cultural and liturgical issues of the future with the very clear mandate that those who lead must do so with a very clear and strong vision, and be able to respond to the changing demands of church musicians as we prepare to enter the new century.

As is the case with most conventions, there was ample time for play and enjoyment with numerous opportunities for networking with our colleagues in the profession. Kansas City is a model of urban planning with many miles of boulevards and parkways lined with statues, and numerous parks with delightful fountains and lush greenery.

The convention was filled with outstanding concerts as a distinguished group of musicians filled the various venues with thrilling sounds. The new Casavant pipe organ at the RLDS Temple was played with great panache and musicianship by John Obetz and Robert Glasgow. David Higgs played a thrilling program at the RLDS Auditorium, home of "The Auditorium Organ with John Obetz." Our own Region VI Councillor, Linda Duckett, played an exciting program at Village Presbyterian Church. This writer was especially moved by her compelling reading of the "Sonata on the 94th Psalm" by Julius Reubke. The Kansas City Chorale, directed by Charles Bruffy, gave a notable performance that included some newer challenging music. James Higdon was at the organ of Saint Michael and All

Angels Episcopal Church as the Chorale sang the "Messe Solennelle" of Jean Langlais.

Many excellent workshops were available to attend. Calvin Johansson's workshop on "Reclaiming Church Music: A Biblical Rationale for Countering Church Pop" was noteworthy. I highly recommend two books by Dr. Johansson: Music & Ministry - A Biblical Counterpoint and Discipling Music Ministry - Twenty-first Century Directions. These books are expansions of the basic thrust of his message at the workshop. John Romeri, new liturgist and organist at the St. Louis Cathedral in St. Louis, Missouri, presented a very practical and helpful workshop entitled "Mind the Gap: Improvisational Skills Reexamined."

The above mentioned highlights were but a part of many additional concerts and workshops which took place during the convention.

For those of you who have never attended a regional or national convention, I highly recommend it for your consideration.

See you in New York City in July of 1996 for the Centennial Convention of the AGO.

SUMMER ORGAN WORKSHOPS DEEMED SUCCESSFUL

Two workshops for adult organists, sponsored by Concordia College, were held in Bozeman, Montana (May 30-31) and Willmar, Minnesota (June 27-28). Thirty-one adults attended the Bozeman workshop, while sixty-one adults attended the Willmar workshop. Sixty-one people is the most people ever attending one of the Concordia workshops. Michael Olson, Peter Nygaard, and Judy Sanders were the three instructors for these workshops. Classes were held concerning liturgy, technique, hymn playing, repertoire, and other topics.

Young Organist Week, for youth in grades seven through twelve, was held June 11-15 at Concordia College and area churches in Fargo-Moorhead. Twenty-eight young people from a five-state region (Montana, North Dakota, South Dakota, Minnesota, and Wisconsin) were in attendance. Instructors for the week included Michael Olson, Peter Nygaard, Judy Sanders, Allen Quie, and June Boyd (who provided the students with an exciting choral experience each day).

This was the sixth year of the organ workshops. Plans will soon be made for the 1996 workshops. It was fun to see several of the adult participants at other workshops this summer: the Augsburg Fortress Church Music Clinic at Central Lutheran in Minneapolis, and the Schmitt Music Clinic at Gethsemane Episcopal Cathedral in Fargo.



Code of Ethics(Adopted by National Council October 23, 1933, revised through June 11, 1992)

PREAMBLE: Founded as an educational & collegial organization, the American Guild of Organists strives to support its members in their professional lives and work. In keeping with this goal, and recognizing the diversity of its membership, the Guild establishes the following rules of conduct, which shall be considered binding upon all members in good standing.

Rule 1. All individuals shall be eligible for membership & participation in the A. G. O.

The Guild (its Headquarters, Regions, Districts & Chapters) shall not discriminate on the basis of race, national origin, age, religious affiliation, gender, marital status, sexual orientation, disability or medical condition (including, but not limited to, Acquired Immune Deficiency Syndrome).

All members are entitled to enjoy the privileges & are expected to accept the responsibilities of membership in the Guild. Members shall be considered equally for Guild offices & participation in Guild activities. Members shall abide by this Code of Ethics, the Code of Professional Standards, the By-Laws of the American Guild of Organists & the operating procedures of their local Chapters.

The Guild's referrals & recommendations for prospective employment shall be based solely upon professional competence & availability. The Guild shall consider members' physical disabilities when choosing sites for its activities, & shall endeavor to make printed materials accessible to members with visual disabilities.

Rule 2. Members shall strive to promote good working relationships within this organization & within their employing institutions.

Members shall observe both the spirit & letter of this CODE OF ETHICS in their dealings with the Guild, with individual members & with musicians under their supervision. In their relationships with employing institutions, members shall abide by the CODE OF PROFESSIONAL STANDARDS.

Members shall address differences of opinion within this organization through appropriate channels, including its Discipline. Members shall address differences of opinion with employing institutions through appropriate channels, as provided by their individual employment agreements & the Guild's PROCEDURES FOR DEALING WITH COMPLAINTS ABOUT EMPLOYMENT MATTERS.

Rule 3. Members shall respect the employment of colleagues.

a. Members shall not apply for a position, appear to be soliciting a position, engage in discussion about possible employment or attempt to place a student or colleague in a position until the incumbent shall have resigned or been notified of termination by the institution. It is the responsibility of the member to determine whether the incumbent has been notified. Furthermore, members shall not undermine or attempt to dislocate an incumbent.

In cases where the National Council has determined that a position has been made vacant by wrongful termination of a member of the American Guild of Organists (see PROCEDURES FOR DEALING WITH COMPLAINTS ABOUT EMPLOYMENT MATTERS), members shall not seek employment or attempt to place a student or colleague in the position until the National Council has declared that differences between the Guild & the institution have been resolved.

b. A member may accept a performing engagement only when such an engagement has been approved by the incumbent musician. It is the responsibility of the member to determine whether approval has been granted.

In cases where such a performing engagement, for a wedding, funeral or other occasional service, has been requested by a third party, it is appropriate for the third party to offer the incumbent the customary fee as a professional courtesy.

Rule 4. Members shall respect the legal rights of others.

- a. Members shall respect the property rights of composers, authors & publishers by being aware of & complying with the Copyright Law & attendant procedures regarding performance, reproduction, & recording rights.
- b. Members shall respect the employment rights of others by being aware of & complying with all laws & procedures pertaining to immigration & work permits.
